**HPAE State Convention**

The Local is entitled to thirty-five (35) delegates and five (5) alternates based on their membership. This year's convention will be held virtually October 7, 2021. Local 5089 Constitution and By-Laws states that all elected local officers are delegates to the convention. There are six (6) elected officers, which mean that twenty-nine (29) delegate positions and five (5) alternate positions are open for election. All expenses are the responsibility of the delegate or alternate. Some reimbursement from the Local maybe available. Any available money will be shared equally among delegates attending. The nomination/election committee is currently accepting nominations for these positions.
