The Nominations/Election Committee announces that they are now accepting nominations to represent Local 5097 at this year's HPAE State Convention. HPAE State Convention

The Local is entitled to five (5) delegates and five (5) alternates based on their membership. This year's convention will be held virtually October 7, 2021. Local 5097 Constitution and By-Laws states that all elected local officers are delegates to the convention. There are three (3) elected officers, which mean that two (2) delegate positions and five (5) alternate positions are open for election.
