The Nominations/Election Committee announces that they are now accepting nominations to represent Local 5131 at this year's HPAE State Convention. **HPAE State Convention**

The Local is entitled to thirty (30) delegates and twelve (12) alternates based on their membership. This year's convention will be held virtually, October 7, 2021. Local 5131 Constitution and By-Laws states that all elected local officers are delegates to the convention. There are four (4) elected officers, which mean that twenty-six (26) delegate positions and twelve (12) alternate positions are open for election. Local will supply financial compensation fees for delegates who attend. All additional expenses are the responsibility of the delegate or alternate. The nomination/election committee is currently accepting nominations for these positions.
