The Nominations/Election Committee announces that they are now accepting nominations to represent Local 5186 at this year's HPAE State Convention. HPAE State Convention

The Local is entitled to eleven (11) delegates and five (5) alternates based on their membership. This year's convention will be held virtually, October 7, 2021. Local 5186 Constitution and By-Laws states that all elected local officers are delegates to the convention. There are three (3) elected officers, which mean that eight (8) delegate positions and five (5) alternate positions are open for election.
